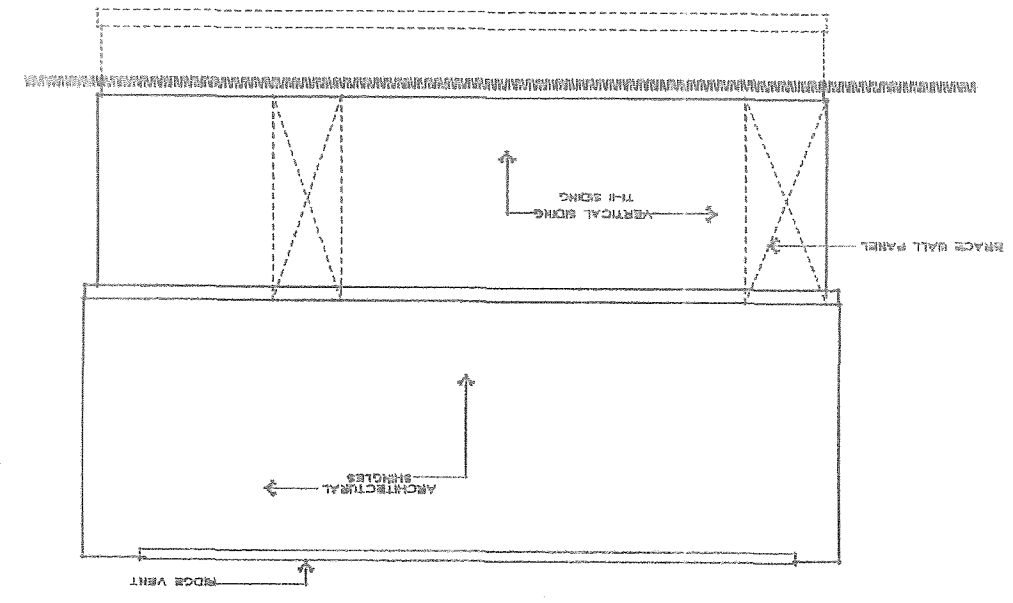
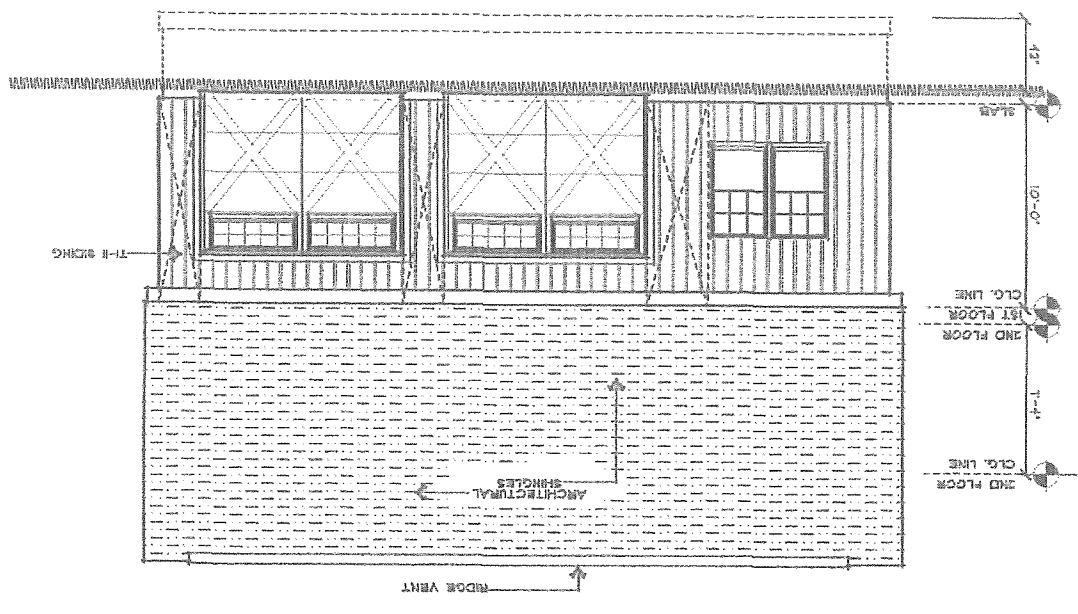

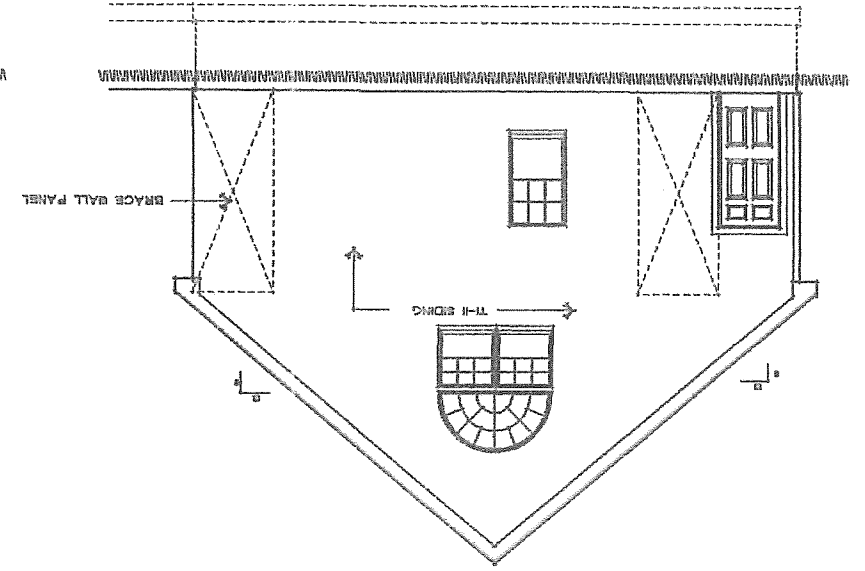
REAR ELEVATION

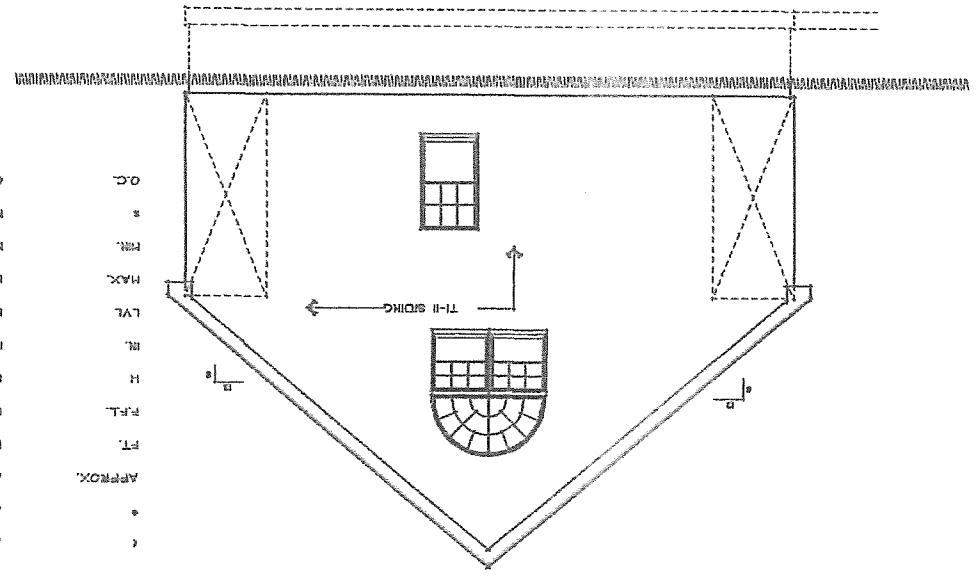
FRONT ELEVATION

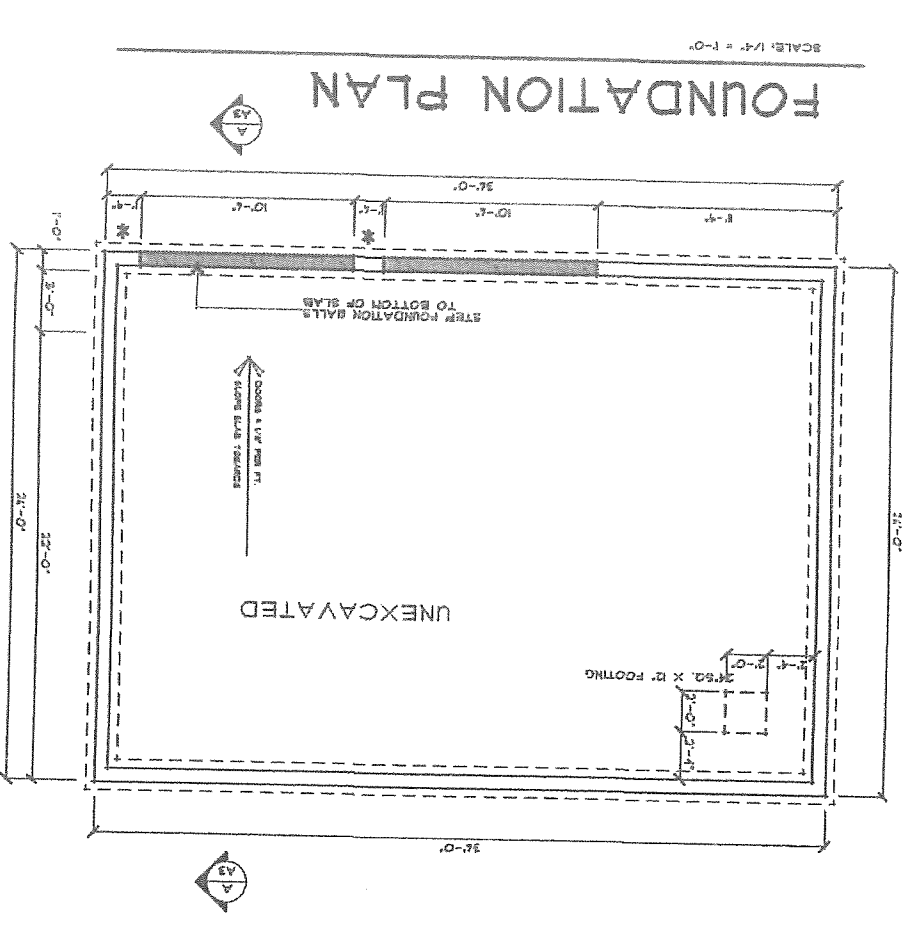
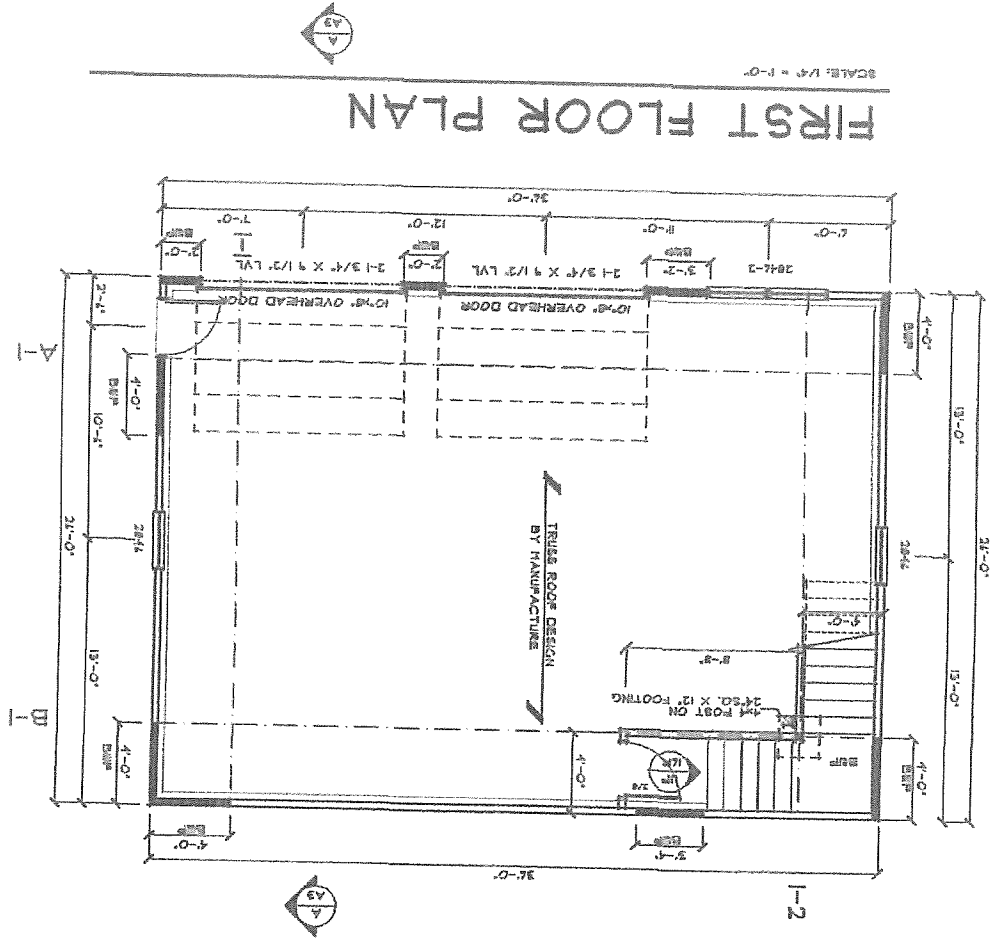

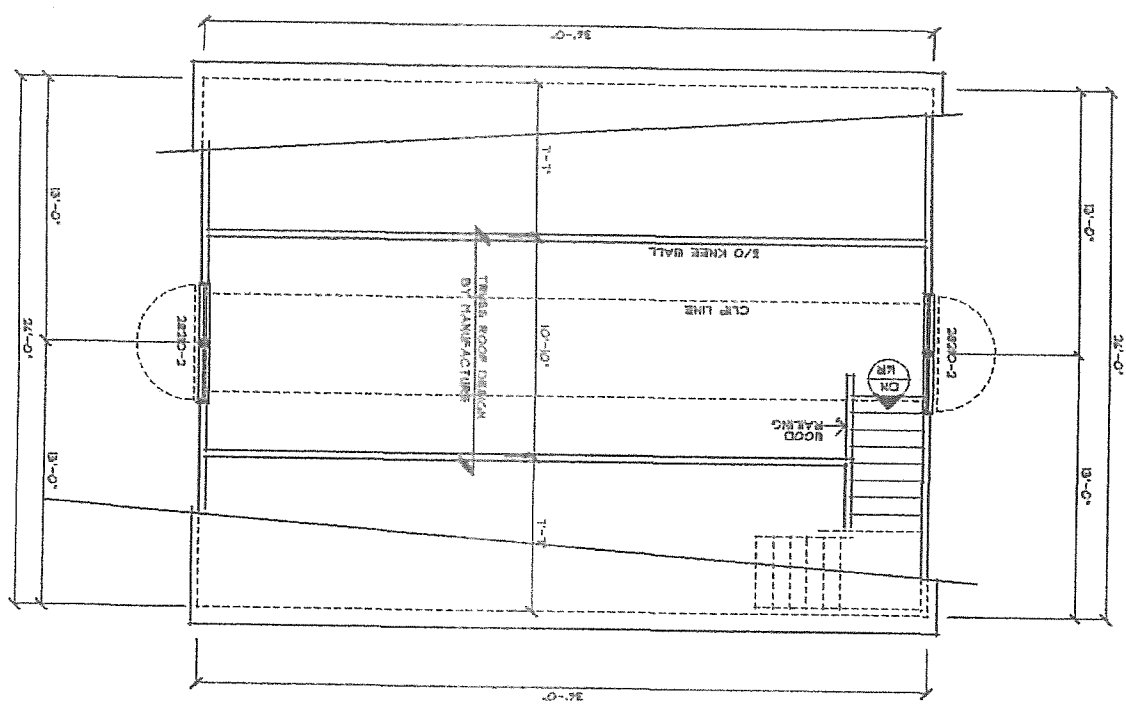

SECOND FLOOR PLAN

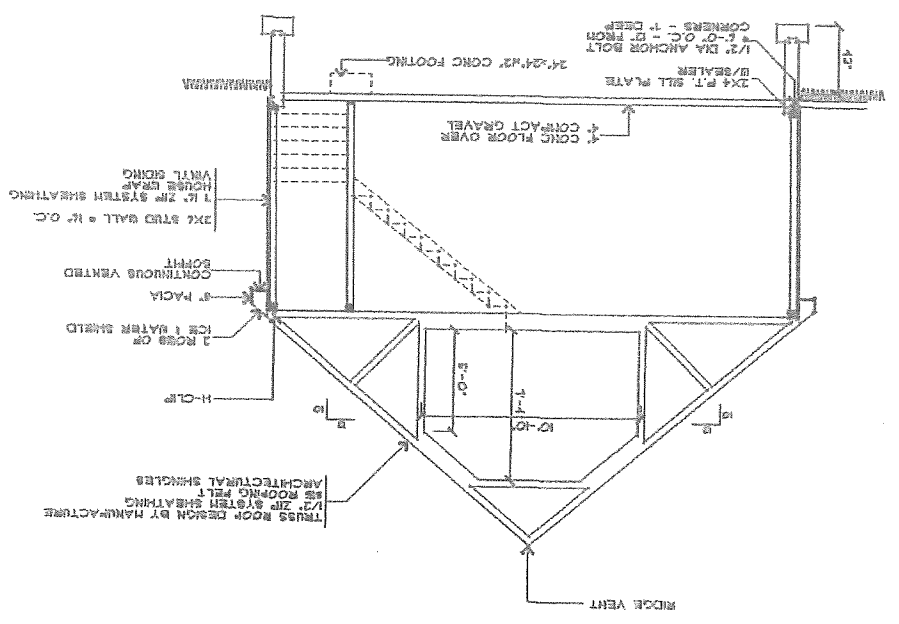
